**PETITION REQUESTING INCLUSION OF TERRITORY IN  
MONTGOMERY COUNTY EMERGENCY SERVICES DISTRICT NO. 7**

**TO THE SECRETARY OF THE BOARD OF EMERGENCY SERVICES  
COMMISSIONERS OF MONTGOMERY COUNTY EMERGENCY SERVICES  
DISTRICT NO. 7:**

**COMES NOW**, the undersigned Petitioners, all being qualified voters and owners of taxable real property within the boundaries of the territory described in Exhibit "A", attached hereto and incorporated herein for all purposes (and herein referred to as the "Territory to be Included"), who hereby respectfully present unto the Board of Emergency Services Commissioners of Montgomery County Emergency Services District No. 7 their Petition for the inclusion in Montgomery County Emergency Services District No. 7 of said territory described in Exhibit "A" pursuant to Section 775.051, Health & Safety Code ("H&S Code"), and ask the Board of Emergency Services Commissioners to receive and act upon the same in accordance with the H&S Code, and as reason therefore would show unto the Board of Emergency Services Commissioners as follows:

**I.**

That Montgomery County Emergency Services District No. 7 (previously known as Montgomery County Rural Fire Prevention District No. 7, having converted from a rural fire prevention district operating under Chapter 794 H&S Code to a district operating under Chapter 775, H&S Code), has been organized in the County of Montgomery, State of Texas, under the provisions of Chapter 775 of the H&S Code, for the protection of life and health as provided in Section 48-e of Article III of the State Constitution, and Chapter 775 of the H&S Code.

**II.**

That the Territory to be Included is adjacent to the boundaries of Montgomery County Emergency Services District No. 7 and the Territory to be Included is situated wholly in Montgomery County, Texas.

**III.**

That this Petition is presented to the Board of Emergency Services Commissioners of Montgomery County Emergency Services District No. 7 and is signed by not less than FIFTY (50) of the qualified voters who own taxable real property within the Territory to be Included, or if there are fewer than 50 qualified voters who own taxable property, the majority of such qualified voters and owners of taxable real property.

**IV.**

That the designated boundaries of the Territory to be Included are set out in the attached Exhibit "A."

**V.**

That none of the Territory to be Included within the proposed District is included within the boundaries of any other emergency services district which provides fire prevention, suppression and extinguishment, hazardous material incident responses and rescue services, and complies with Sections 775.020 and 775.0205 of the H&S Code.

**VI.**

That the Territory to be Included will become a part of Montgomery County Emergency Services District No. 7, fully included in the operations and impositions of Montgomery County Emergency Services District No. 7 as provided under the provisions of Article III, Section 48-e, of the Constitution of the State of Texas and Chapter 775 of the H&S Code.

**VII.**

That the inclusion of Territory to be Included in Montgomery County Emergency Services District No. 7 will promote the protection of human life and health and the public safety, welfare, health, and convenience of persons residing in Territory to be Included and in Montgomery County Emergency Services District No. 7.

**VIII.**

That the names and mailing address of each of the undersigned Petitioners being qualified voters owning taxable real property within the Territory to be Included (as described in Exhibit "A"), are hereinafter set forth:
